

Privacy Statement

Oefenweb.nl B.V., hereafter: Oefenweb.nl, respects the privacy of its Subscribers, its Users, and its demo Users and shall at all times treat their personal details as confidential with due regard for the Personal Data Protection Act (Wbp).

1. Purposes of data processing

Oefenweb.nl processes the personal details of its Subscribers and their Users to enter into and implement Subscription Agreements for the use of Oefenweb.nl's Web Products, including the Maths Garden. These include, among other things, the Subscriber's address details, and the furnished email addresses and telephone numbers of its Users. In addition, the players' date of birth, gender, school year, play performance, and any other information about the players furnished by the Subscriber are saved. These data are needed for the best possible performance of the Web Products and will also be used for research purposes; see 1.2.

Oefenweb.nl processes the name, play performance, the email address and any other information about the demo Users furnished by the demo User. These data are needed for the best possible performance of the Web Products and will also be used for information provision; see 1.3.

1.1 Login procedure

If the Subscriber is a school or institution, Oefenweb.nl will publish the name of the school on its website for the login procedure for its Web Products. If the Subscriber does not wish this to be done it can so notify Oefenweb.nl in writing or via email.

1.2 Research

Oefenweb.nl anonymises the data collected with its Web Products, such as the Maths Garden, and uses them for scientific research. Anonymised means that the data can no longer be tracked back to a specific person. This involves, among other things, removing the names and any contact details for the Users of the Web Products. The anonymised data shall be used solely to improve the Web Products and for scientific research. Furthermore, Oefenweb.nl can make the anonymised data available to third parties for scientific research.

If the Subscriber is a school or institution, it is also responsible for informing its Users about the use of the data for research. The parents of Users who are minor children must be informed. The parents/Users must also be informed that their participation in scientific research is voluntary and that they can end their participation in such research at any time. The data for these Users will thenceforth no longer be included in the research.

The information that Oefenweb.nl makes available for parents on the sites for its Web Products can be used to inform Users. For example, a reference can be made to this in a newsletter or personal letter.

1.3 Information provision

Oefenweb.nl also uses the personal details to provide its Subscribers and (demo) Users with information about the Web Products to which they have a subscription or a Users account, and any other products and services of Oefenweb.nl B.V. If the Subscriber or the User does not wish this to be done it can so notify Oefenweb.nl in writing or via email.

1. 4 Payment information

Payments for Oefenweb.nl's Web Products are made through Buckaroo. Buckaroo is a specialist in online payments and provides a secure payments environment. Because it has a secure SSL connection, all payment information is transmitted encrypted. Sensitive bank and/or credit card details are not visible to Oefenweb.nl.

1. 5 Cookies

Cookies are small bits of information that can be saved on your computer by your browser. Oefenweb.nl uses cookies to increase the User experience with its Web Products.

1.6 IP addresses

Oefenweb.nl reserves the right to store IP addresses for up to 6 months for the purpose of detecting infringements of the Subscription Agreement as well as infringements of intellectual property rights.

2. Availability to third parties

Oefenweb.nl shall not make personal details available to third parties, unless:

- this is necessary to carry out the order,
- the Subscriber grants its written permission to do so,
- Oefenweb.nl is required by law to furnish the data.

3. Inspection and correction

The Subscribers and their Users may inspect at any time the personal information saved by Oefenweb.nl in the administrative section of the Web Products. Any inaccuracies can be changed here. Demo Users can request this information from Oefenweb.nl via email and make necessary corrections.

4. Amendment of the privacy statement

Oefenweb.nl reserves the right to amend this privacy statement. Any amendment shall be published on the website(s) of the Web Product(s).
